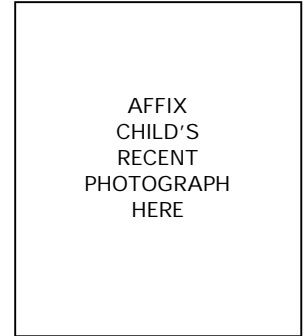

AGREEMENT

This Agreement is between:

Shri/Smt _____ Father/Mother/Guardian on the one part, and the Principal, on behalf of the Board of Governors of St. Thomas' College, Dehra Dun on the other. Now, it is hereby agreed that:

My ward _____ having been admitted as a student in St. Thomas' College, at 2 Cross Road, Dehra Dun.

I, Shri/Smt. _____ agree to the following Terms & Conditions:

1. That I shall observe all the rules and regulations prescribed by St. Thomas' College.
2. That I shall pay all the fees and all other costs as per the requirements of the College.
3. That the placing of my son/daughter/ward after a test, if necessary into a class suitable to his/her age and attainments as a result of the test shall be at the sole discretion of the Principal.
4. That the Principal can, at any time in the interest of the College, remove my ward after due intimation to me if my ward has failed to accept the norms laid down by the College. In case my ward does not get promotion to the next higher class, I agree to withdraw him/her from the College.
5. That I accept the condition that in the event of my ward having to leave the College as per para 4 above or for any other reason whatsoever, I shall not claim any refund of money and dues paid to the College for the term, except the security money.
6. That no transfer certificate will be issued unless and until all dues to the College are paid in full.
7. That neither the Principal nor the Board of Governors of St. Thomas' College individually or severally will be held responsible for any sickness, infection or injury sustained by my ward while taking part in studies, sports and extra-curricular and other forms of activity of the College within or outside the College premises and further that I shall be willing in such circumstances to pay all the expenses incurred in the treatment of such injuries, without question.
8. And that if there is any dispute as to the effect or meaning of these presents or in any way touching or arising out of these presents, the same shall be referred to the sole arbitration of the President of St. Thomas' College, Dehra Dun whose decision shall be final.
